**TERMS AND CONDITIONS**

The parties herein agree as follows:

The initial term of this contract shall be for care of \_\_\_\_\_ in my home from

The daily fee is \$50 per pet and starts upon drop-off. Pets that are picked up before 10am will not incur a charge for that day. Pickup after 10am is considered an additional day of boarding and will be charged accordingly. Pickups and drop-offs are generally available from 8am until 8pm daily and must be scheduled in advance. Holiday pickup or dropoff is an additional \$25 charge.

All fees are expected to be paid, by cash, check or money order, at the time the contract is completed.

Covalent Pet Care, LLC, herein cited as CPC, is authorized to perform care and services as outlined on this contract. While every effort will be made to contact Client in the event of an emergency, if Client cannot be reached, CPC is also authorized by signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment and expenses. Should specified veterinarian be unavailable CPC is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by veterinarian. Client agrees to reimburse CPC for expenses incurred, plus any additional fees for attending to this need or any expenses incurred for any other food/supplies needed.

Covalent Pet Care, LLC agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express consideration thereof, the Client expressly waives and relinquishes any and all claims against CPC except those arising from negligence or willful misconduct on the part of Ashley Eike or her agents. In addition, I also understand that while under the care of CPC my dog will co-mingle with animals of different ownership, and be housed in appropriately sized kennels at necessary times. Any dog group play or daycare situation is entered into with the express understanding that CPC accepts no liability for any dog fight injuries or contagious illness that might occur. Furthermore, your pet may be kenneled during mealtimes or when not able to be supervised. You may provide your pet's own crate, which must be of appropriate size, or one will be provided for you by CPC. If your pet is not crate-trained or has severe anxiety when crated, you agree to advise CPC in advance so alternate arrangements can be made for those instances when your pet will need to be separated from the other pets in the facility.

The utmost care will be given in watching your pet. However, due to the extreme unpredictability of animals, we cannot accept responsibility for any mishaps of an extraordinary or unusual nature (i.e. bitings, furniture damage, accidental death, etc.) or any complications in administering medications to the animal. In the event that transport is required or requested at any time, your pet will be secured in a crate or a seatbelt harness and the vehicle will be climate controlled appropriate to the current conditions.

All pets are to be currently vaccinated for Rabies and be free of all communicable diseases and parasites. You must provide proof of veterinary administration of the Rabies vaccination for Covalent Pet Care, LLC to keep on file. For puppies under 6 months, we also require proof of vaccination for Distemper/Parvo and a negative fecal test within the month prior to boarding with Covalent Pet Care, LLC. This is to insure that your puppy is as protected as possible against the most prevalent dog diseases and for me to insure that intestinal parasites are not brought into our home.

Covalent Pet Care, LLC reserves the right to terminate this contract at any time before or during its term if at its discretion it determines that Client's pet(s) pose a danger to the health or safety of CPC's staff or personal dogs. If concerns prohibit CPC from caring for Pet, including containment issues (fence climbing/jumping), illness or aggression, Client authorizes the pet to be placed in South Mesa's boarding kennel or hospital quarantine, with all boarding fees to be charged to Client.

As required by the Colorado Department of Agriculture, PACFA Regulations, Description 16.00 G. 3., in the event of death, Covalent Pet Care, LLC will provide interim body care (cold storage at South Mesa Veterinary Hospital) until the owner is reached and final plans are made.

Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract, permitting Ashley Eike to accept telephone or email reservations for service and care for Pet without additional signed contracts or written authorization.

## **Pet Boarding Checklist**

*Don't forget to bring:*

- Your pet's food in a waterproof container(enough for their entire stay)
- Food bowl (I've got the water bowl covered)
- Medications (if applicable)
- Crate (if applicable) or a bed from home
- Any treats or toys that you think your pet would like. Nothing sentimental, as these will be communal and may be chewed/destroyed.
- Proof of Vaccinations
- Signed Contract
